Notes:

It appears that after his wife died, possibly as result of giving birth to their last child, John, William B. Miles more or less abandoned his children, who were taken in by relatives, so that he could cohabit with widow Sarah Baker. In 1857 the Franklin County court appointed John H. Duncan as guardian of both Elizabeth and John W. Miles (minor heirs of William B. Miles, dec."), although it does not appear that they lived with their guardian. Instead, it appears that Duncan merely took care of the money that the two children had inherited from their grandfather, John Farrar.

There is some uncertainty as to when William B. Miles died. A deed on file in Franklin County, TN shows him selling land in October 1858, but court records dated 1857 remark that he was deceased. One or the other of these records must be in error.

William B. Miles' date and place of death and place of burial has been lost to history.

As of this date (6/14/2019), Coffee County, TN deed records have not been checked to see what land he may have owned there. Obviously, more research is needed on this individual.
